ORDINANCES & RESOLUTIONS PASSED NOVEMBER 26, 2018

- 1 ORD 399-2018 amending/supplementing Title 7, "Traffic Code," Chapter 76, "Parking Regulations," Section 76.221, "Parking Large Vehicles in Residence Districts" by updating limitations on what kind of large vehicles may be allowed to park in residential districts; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 2 ORD 400-2018 providing for the temporary appropriation for the current expenses, other expenditures and the capital outlays of the City of Akron for the period of January 1, 2019 through March 31, 2019; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 3 ORD 401-2018 authorizing the Mayor or his designee, without the formality of publicly advertising for bids, to enter into a contract or contracts to purchase the property located at 201 S. Main Str., Akron, OH 44308, known as the Carlton Building, from JMS Place Limited ("JMS") and then immediately sell it to Pritt Properties, LLC ("Pritt"), allowing Pritt to carry out the Downtown Renewal Plan as set forth in Ordinance No. 255-2014; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 4 ORD 402-2018 authorizing the purchase of vacant lots on Kelly Avenue and Weeks Street for the CSO Rack 3 (Kelly Green) Project; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 5 ORD 403-2018 approving the sale of City-owned property located at 146 South High Street, Akron, OH 44308; determining said property is not needed for public use; and declaring an emergency. VOTE 12-0 (Sommerville absent)
- 6 ORD 404-2018 authorizing the Mayor to execute and deliver a Cooperative Agreement related to the establishment of the Firestone Business Park; authorizing the sale of certain real property of the City, such property being no longer needed for public use; and declaring an emergency. VOTE 11-0 (Kammer abstained) (Sommerville absent)
- 7 RES 405-2018 approving and confirming the reappointment of Robert

DeJournett and Nicholas Fernandez to the Metropolitan Regional Transit Authority ("Metro") Board of Trustees; and declaring an emergency.
VOTE 12-0 (Sommerville absent)

8 ORD 406-2018 authorizing the Purchasing Agent to enter into a contract or contracts, after publicly advertising for bids, for the purchase of certain audio-visual equipment and related services, including interactive projectors, televisions, receivers, speakers, cables, and other hardware and software for use by the Akron Police Department; and declaring an emergency. VOTE 12-0 (Sommerville absent)

9 ORD 407-2018 authorizing the Mayor to enter into a contract with Interval Brotherhood Home to provide comprehensive residential drug and alcohol treatment to eligible individuals; and declaring an emergency. VOTE 12-0 (Sommerville absent)
