### ORDINANCES & RESOLUTIONS PASSED JUNE 24, 2019

- 1      ORD 184-2019 authorizing the Director of Finance, or her designee, to pay \$15,000.00 for an operating subsidy to Cascade Locks Park Association, in order to support the maintenance of the Cascade Locks and Mustill Store Museum as a welcoming recreational and culturally educational urban green space; and declaring an emergency. VOTE 13-0
  
- 2      ORD 185-2019 authorizing the Director of Finance, or her designee, to enter into a contract with the Akron/Summit Convention & Visitors Bureau, Inc. to pay an operating subsidy for the convention bureau in order to support the services and offerings of the convention bureau to the residents and visitors of the greater Akron area; authorizing payment therefor; and declaring an emergency. VOTE 13-0
  
- 3      ORD 186-2019 authorizing the issuance and sale of notes in a maximum principal amount of \$2,500,000, in anticipation of the issuance of bonds, to retire notes issued for the purpose of providing funds to pay expenses associated with the settlement of health care claims, whether by reserve or otherwise, and the City's portion of the costs of maintaining its self-insurance program for employee health care benefits; and declaring an emergency. VOTE 13-0
  
- 4      ORD 187-2019 providing for the issuance and sale of notes in a principal amount not exceeding \$13,000,000 to pay the property owners' portion, in anticipation of the levy and collection of special assessments, of the cost of improving certain streets in the City, between certain termini, by providing street-cleaning services and street lighting; and declaring an emergency. VOTE 13-0
  
- 5      ORD 188-2019 authorizing the Director of Public Service, or his designee, to enter into a contract or contracts after publicly advertising for bids, for the repair and/or replacement of three (3) expansion joints in the High Market Parking Deck; and declaring an emergency. VOTE 13-0
  
- 6      ORD 189-2019 authorizing the Director of Public Service or his designee, without the formality of publicly advertising for bids, to enter into a contract with the Otis Elevator Company for the emergency repair of

elevators located in the Cascade Parking Deck; and declaring an emergency. VOTE 13-0

- 7 ORD 190-2019 authorizing the Director of Public Service to enter into a contract or contracts, after publicly advertising for bids, for the construction of the Opportunity Parkway Steam Condensate Project; approving specifications therefor; and declaring an emergency. VOTE 13-0
- 8 RES 191-2019 approving and confirming the re-appointment by Mayor Horrigan of Brant T. Lee and Nanette Pitt as a members of the Akron Civil Rights Commission; and declaring an emergency. VOTE 13-0
- 9 ORD 192-2019 authorizing the Purchasing Agent, without the formality of publicly advertising for bids, to enter into a contract or contracts, with Stalker Radar for the purchase of seven (7) antenna radar units and related parts; and declaring an emergency. VOTE 13-0
