#9-2021

Under the authority granted by Title 7, Code of Ordinances of Akron, Ohio, 1993, the following traffic control regulations are hereby made:

REPEAL

No Parking Any Time – Classification 25

Ellsworth Court, both sides, from Kenmore Blvd. to the southern end of Ellsworth Court. (Ord. 445-1957)

No Parking from 7:00 A.M. to 9:00 A.M. – Classification 26

Market Street, East, north side, from Elm Drive to Martha Avenue. (Order #46-1970)

Market Street, East, north side, from Summit Street to a point 75 feet east of Broadway, (Order #14-2005)

No Parking from 4:00 P.M. to 6:00 P.M. – Classification 28

Market Street, East, north side, from Summit Street to a point 75 feet east of Broadway, (Order #14-2005)

Market Street, East, south side, from Spruce Street to S. Adams Street. (Order #54-1971)

Market Street, East, south side, from Franklin Avenue to Spruce Street. (Order #2-1972)

Market Street, East, north side, from Carroll Street to Arlington Street. (Order #4-1964)

Parking for Handicapped Persons – Classification 63-1

State Street, north side, from a point 40 feet west of the west property line of South Main Street to a point 40 feet west thereof. (Order #38-1992)

State Street, south side, from a point 40 feet west of the west property line of South Main Street to a point 40 feet west thereof. (Order #7-1999)

Left Turns Prohibited – Section 64

Arlington Street, South, to proceed east into the Co-Op Super Market driveway at Wilbeth Road. (Order #7-1969)

Bell Street to proceed west on Livingston Avenue. (Order #9-1989)

From Martin Avenue to proceed north on South Arlington Street. (Ord. 20-1994)

From northbound Arlington Street to proceed west on Hazel Street. (Order #7-1968)

From south on North Howard Street to proceed northeast to the underpass roadway from North Howard Street to the Main Street High Level Bridge. (Order #63-1958)

From the westbound off-ramp of the West Expressway to proceed south on Grant Street. (Order #44-1971)

Maiden Lane Alley, to proceed west on West Market Street. (Order #23-1973)

No Left Turns 4:00 to 6:00 PM – Section 67

From Canton Road to proceed west on Mogadore Road. (Order #4-1973)

No Left Turns 7:00 to 9:00 AM – Section 67-1

Brittain Road to proceed west on Bauer Boulevard. (Order #5-1987)
