TRAFFIC CONTROL REGULATION

#9-2023

Under the authority granted by Title 7, Code of Ordinances of Akron, Ohio, 1993, the following traffic control regulations are hereby made:

No Parking Any Time – Classification 25

Carroll Street, north side, from the west property line of Annadale Avenue to a point 175 feet west thereof.

Right Turn Prohibited on Red Signal – Section 25-3

Bowery Street, West, to proceed east on to West State Street.

Bowery Street, West, to proceed west on to West State Street.

State Street, West, to proceed north on to West Bowery Street.

State Street, West, to proceed south on to West Bowery Street.

REPEAL

Bus Stop - No Parking – Classification 24

7th Avenue, north side, from a point 150 feet east of the east property line of Weeks Street to a point 60 feet east thereof. (Order #1-2009)

7th Avenue, south side, from the west property line of Kelly Avenue to a point 60 feet west thereof. (Order #1-2009)

Tallmadge Avenue, north side, from a point 290 feet west of the west property line of Grand Park Avenue to a point 60 feet west thereof. (Order #1-2009)

Tallmadge Avenue, north side, from the intersection of the property lines of Tallmadge Avenue and Blaine Avenue to a point 60 feet east thereof. (Order #1-2009)

No Parking Any Time – Classification 25

Carroll Street, south side, from Grant Street to Brown Street. (Order #5-1969)

Carroll Street, north side, from the west property line of Annadale Avenue to a point 40 feet west thereof. (Order #13-1976)

Carroll Street, north side, from the extended east property line of Beaver Street to a point 49 feet west thereof. (Order #1-1991)

Shaw Avenue, south side, from the east property line of Brittain Road to a point 50 feet east thereof. (Order #32-1959)

Shaw Avenue, south side, from the west property line of Watson Street to a point 40 feet west thereof. (Order #3-1985)

Stop Streets – Section 59

Buchtel Avenue (westbound traffic) at intersection of Sumner Street. (Order #14-1972)

Buchtel Avenue (eastbound traffic) at intersection of Sumner Street. (Order #14-1972)

Sumner Street at intersection of Buchtel Avenue. (Order #14-1972)

Right Turn Lanes – Section 61-2

On North Main Street, a distance of 150 feet south of its intersection with Furnace Street, the east curb lane. (Order #29-1969)

State Street, West, a distance of 100 feet east of its intersection with Water Street. (Order #26-1974)
