ORDINANCE NO. \_\_\_\_\_\_\_-2023, amending and/or supplementing Title 1, Chapter 11 of the Code of Ordinances of the City of Akron, Ohio by enacting new Sections 11.01 through and including 11.10, to subdivide the City into wards in conformity with the 2020 Federal Census and Akron Charter Section 28a; amending and/or supplementing Section 1 of Ordinance No. 224-2022, passed July 25, 2022; and declaring an emergency.

WHEREAS, Section 28a of the Charter of the City of Akron provides that the Council shall subdivide the City into Wards following each decennial census; and

WHEREAS, the 2020 census indicates changes in the populations of several Wards as now constituted; and

WHEREAS, pursuant to Section 28a of the Charter of the City of Akron, Council, on July 25, 2022, passed Ordinance No. 224-2022, which subdivided the City into wards and adopted a map indicating the new ward boundaries; and

WHEREAS, Ordinance No. 224-2022 repealed existing Sections 11.01 through and including 11.11 of the Code of Ordinances of the City of Akron and authorized the Director of Law to prepare legal descriptions of the Wards; and

WHEREAS, Ordinance No. 224-2022, provides for the change in Ward boundaries to be effective for the municipal primary election to be held on May 2, 2023.

NOW, THEREFORE, BE IT ENACTED by the Council of the City of Akron, Ohio:

Section 1. That Title 1, Chapter 11 of the Code of Ordinances of the City of Akron, Ohio is hereby amended and/or supplemented by the enactment of Sections 11.01, 11.02, 11.03, 11.04, 11.05, 11.06, 11.07, 11.08, 11.09, and 11.10 which shall read as follows:

### Section 11.01 Ward One

The First Ward shall be bounded and described as follows:

Beginning at the intersection of the North Corporation Line and the centerline of North Portage Path;

Thence southerly along the centerline of North Portage Path to the intersection of the centerline of North Portage Path and Merriman Road;

Thence southerly along the centerline of Merriman Road to the centerline of the intersection of Merriman Road and Memorial Parkway;

Thence westerly along the centerline of Memorial Parkway to the intersection of the centerline of North Portage Path;

Thence southerly along the centerline of North Portage Path to the intersection of the centerline of Twin Oaks Road;

Thence westerly along the centerline of Twin Oaks Road to the intersection of the centerline of West Market Street;

Thence southeasterly along the centerline of West Market Street to the intersection of the centerline of Orchard Road:

Thence southwesterly along the centerline of Orchard Road to the intersection of the centerline of Mull Avenue;

Thence easterly along the centerline of Mull Avenue to the intersection of the centerline of West Market Street;

Thence southeasterly along the centerline of West Market Street to the intersection of the centerline of Marvin Avenue;

Thence southwesterly along the centerline of Marvin Avenue to the intersection of the centerline of Corson Avenue;

Thence southerly along the centerline of Corson Avenue to the intersection of the centerline of Bloomfield Avenue;

Thence westerly along the centerline of Bloomfield Avenue to the intersection of the centerline of West Exchange Street;

Thence southeasterly along the centerline of West Exchange Street to the intersection of the centerline of Grand Avenue;

Thence easterly along the centerline of Grand Avenue to the intersection of the centerline of Portage Path;

Thence southerly along the centerline of Portage Path to the intersection of the centerline of West Exchange Street;

Thence southeasterly along the centerline of West Exchange Street to the intersection of the centerline of Maple Street;

Thence easterly along the centerline of Maple Street to the intersection of the centerline of Glendale Avenue;

Thence southeasterly along the centerline of Glendale Avenue to the intersection of the centerline of Locust Street;

Thence southerly along the centerline of Locust Street to the intersection of the centerline of Wills Avenue;

Thence southwesterly along the centerline of Wills Avenue to the intersection of the centerline of the northern lane of Martin Luther King Boulevard;

Thence continuing in a southerly fashion to the intersection of the centerline of the southern lane of Martin Luther King Boulevard and the extension of West State Street;

Thence southeasterly along the centerline of West State Street to the intersection of the centerline of West Bowery Street;

Thence northerly then westerly along the centerline of West Bowery Street to the intersection of the centerline of South Main Street;

Thence southerly along the centerline of South Main Street to the intersection of the centerline of East Exchange Street;

Thence easterly along the centerline of East Exchange Street to the intersection of the centerline of Wolf Ledges Parkway;

Thence southerly along the centerline of Wolf Ledges Parkway to the intersection of the centerline of Wheeler Street;

Thence southeasterly along the centerline of Wheeler Street to the intersection of the centerline of Sherman Street;

Thence southwesterly along the centerline of Sherman Street to the intersection of the centerline of Wheeler Street;

Thence easterly along the centerline of Wheeler Street to the intersection of the centerline of Brown Street;

Thence northerly along the centerline of Brown Street to the intersection of the centerline of East Exchange Street;

Thence southeasterly along the centerline of East Exchange Street to the intersection of the centerline of State Route Eight;

Thence northerly along the centerline of State Route Eight to the intersection of the centerline of East Market Street;

Thence northwesterly along the centerline of East Market Street to the intersection of the centerline of North Main Street;

Thence northerly along the centerline of North Main Street to the intersection of the centerline of Howard Street;

Thence northerly along the centerline of Howard Street to the intersection of the centerline of Beech Street;

Thence westerly along Beech Street and transitioning along the southern boundary of United States 2020 Census Block 391535074001033 then northerly along the western boundary of United States 2020 Census Block 391535074001033 and Census Block 391535074001017 to the intersection of the centerline of North Street;

Thence easterly along the centerline of the North Street to the intersection of the centerline of North Howard Street;

Thence northerly along the centerline of North Howard Street to the intersection of the centerline of Cuyahoga Street;

Thence northwesterly along the centerline of Cuyahoga Street to the intersection of the centerline of Reid Terrace;

Thence westerly along the northern boundary of United States 2020 Census Block 391535074001018 to the intersection of the centerline of the Cuyahoga River;

Thence northerly along the centerline of the Cuyahoga River to the intersection with the centerline of Memorial Parkway;

Thence southeasterly along the centerline of Memorial Parkway to the intersection with the centerline of Uhler Avenue;

Thence northerly along the centerline of Uhler Avenue to the intersection with the centerline of Cuyahoga Street;

Thence northerly along the centerline of Cuyahoga Street and transitioning to the centerline of Northampton Road and following the eastern boundary of United States 2020 Census Block 391535075011004 to its intersection with the centerline of Portage Trail Extension;

Thence northerly, westerly, easterly, and southerly along the north Corporation Line back to the point of beginning.

Excepting therefrom certain geographical areas within said ward boundaries not under the jurisdiction of the City of Akron; more fully portrayed on the Ward Boundary Map.

#### Section 11.02 Ward Two

Beginning at the intersection of the North Corporation Line and the centerline of Cuyahoga Street;

Thence southerly along the centerline of Cuyahoga Street to the intersection of the centerline of Uhler Avenue;

Thence easterly along the centerline of Uhler Avenue to the intersection of the centerline of Selzer Street;

Thence northerly along the centerline of Selzer Street to the intersection of the centerline of Lorenz Avenue;

Thence easterly along the centerline of Lorenz Avenue to the intersection of the centerline of Springdale Street;

Thence northerly along the centerline of Springdale Street to the intersection of the centerline of Mildred Avenue;

Thence easterly along the centerline of Mildred Avenue to the intersection of the centerline of Carpenter Street;

Thence easterly then southerly along the centerline of Chapman Drive to the intersection of the centerline of Eastland Avenue;

Thence northeasterly along the centerline of Eastland Avenue to the intersection of the centerline of Nutwood Road;

Thence southeasterly along the centerline of Nutwood Road to the intersection with the Corporation line;

Thence northeasterly, northerly, westerly, and southerly along the north Corporation Line to the place of beginning.

Thence southerly along the centerline of the Ohio & Erie Canal to its intersection with the southern boundary of United States 2020 Census Block 391535059002000;

Thence northeasterly along the southern boundary of United States 2020 Census Block 391535059002000 and United States Census Block 391535059002001 to its intersection with the centerline of Firestone Parkway;

Thence northerly along the centerline of Firestone Parkway to the intersection of the centerline of Cole Avenue;

Thence easterly along the centerline of Cole Avenue to the intersection of the centerline of Andrus Street;

Thence northerly along the centerline of Andrus Street to the intersection of the centerline of Stanton Avenue;

Thence westerly along the centerline of Stanton Avenue to the intersection of the centerline of Moore Street;

Thence northerly along the centerline of Moore Street to the intersection of the centerline of Steiner Avenue;

Thence westerly along the centerline of Steiner Avenue to the intersection of the southeastern point of United States 2020 Census Block 391535068001063;

Thence northerly along the eastern boundary of United States 2020 Census Block 391535068001063 to the intersection of the centerline of Miller Avenue;

Thence easterly along the centerline of Miller Avenue to the intersection of the centerline of Bellows Street;

Thence southerly along the centerline of Bellows Street to the intersection of the centerline of Miller Avenue:

Thence easterly along the centerline of Miller Avenue to the intersection of the centerline of Grant Street;

Section 3. This ordinance is hereby declared to be an emergency measure for the reason that the legal description provided for herein is immediately necessary to permit the necessary work of redistricting to be accomplished immediately in order to assist the Board of Elections; and provided this ordinance receives the affirmative vote of two thirds of the members elected or appointed to Council, it shall take effect and be in force immediately upon its passage and approval by the Mayor, otherwise it shall take effect and be in force at the earliest time allowed by law.


